BEGIN WORK SESSION

Melinda McCarty-Stewart and central office administration discussed with the Board a plan to move preschool to Holmes Elementary in order to close East End Elementary that has only housed the preschool for the past two years. They explained that enrollment is down significantly and with moderate alterations, it is feasible to add these classrooms to Holmes Elementary. This would also allow for a smooth transition for pre-school students to kindergarten and would allow preschool teachers and kindergarten teachers to collaborate more.

Mrs. Zeigler is worried about over-crowding at Holmes and wanted more details about the renovations and where the preschool would be housed. Other Board Members agreed and a walk through of Holmes Elementary was scheduled for May 17, 2022 at 5:15 pm.
