- 1. HB920 Explanation

 - b. HB920 says that schools will not receive an increase in property tax revenue when valuations increase (other than NEW construction). The school would would receive the same amount of revenue and the mileage rate will be adjusted.
 - c. HB920 also doesn't allow a school's effective rate to fall below 20mills. If this happens, the districts effective rate is raised back up to 20 mills and the district will see receive the additional revenue.
- 2. Property Tax Additional Revenue of approximately \$2.5 million annually
- 3. Proposed Recommendations Remove the income levy from the March ballot. Put a hold on proposed school fees, extra-curricular fees, and transportation cuts.
